

## CHAPTER 1

### PARK AND PLAYGROUND REGULATIONS

#### SECTION:

#### 8-1-1: Park and Playground Regulations

**8-1-1: PARK AND PLAYGROUND REGULATIONS:** The following rules and regulations shall be adhered to in all parks, playgrounds and recreational areas within the corporate limits of the Village, namely:

(A) No person shall write upon or mark or deface in any manner or use in any improper way any water closet, seat, fence or any property or thing pertaining to or in any park, playground or recreational area in the Village.

(B) No person shall break, cut, mutilate or injure, remove or carry away any tree, plant, shrub, fence or any property in or upon any park or recreational area in the Village.

(C) No person shall use any abusive, threatening, insulting, indecent, profane, or obscene language, calculated to occasion a breach of the peace, nor be guilty of any indecent act or behavior on the said park and recreational area.

(D) No person shall deposit, dump, throw or place rubbish in or upon any part of the said park and recreational areas. Paper, garbage or refuse matter shall not be so deposited except in receptacles provided for that purpose.

(E) No person shall apply any placard or advertisement of any kind in the said park and recreational areas, nor shall any person distribute, cast, throw, or place any handbill, pamphlet, circular, advertisement, or notice of any kind, nor post, stencil, or otherwise affix any notice, or bills, advertisements or other papers, upon any structure or thing in or about the park and recreational premises, except with the permission of the Playground Commission and the Village Playground Trustees.

(F) No person shall set up any booth or table for the sale of any article whatsoever or vend from a vehicle in any of said parks and recreational areas, except when authorized by the Playground Commission and the Village Playground Trustees.

(G) No person shall foul in any manner any drinking fountain or spray pool in the said park and recreation areas.

(H) No person shall play at games of chance or use any gambling device in said park and recreation areas.

(I) No person, unless by authority of the Playground Commission and the Village Playground Trustees shall light, kindle, or use any fire on any of said park and recreational areas except in those places provided for that purpose.

(J) No person shall bring any dog into any said parks and recreational areas, except when fastened or lead by a cord, string or chain sufficient to properly restrain same.

(K) No person shall enter upon any portion of said parks and recreational areas, where persons are prohibited from going as indicated by sign, notice or fence.

(L) No person shall engage in any sport, game or amusement in said park and recreation areas except in such portions thereof as may be designated for this purpose.

(M) No intoxicated person shall enter, be or remain in the said park and recreation areas, nor shall any person bring within, sell, give away, or drink any intoxicating liquors in the said park and recreation areas.

(N) No person shall make, countenance or assist in making any improper noise, riot, disturbance, breach of the peace, or diversion tending to the breach of the peace in the said park and recreation areas, or be guilty of any disorderly conduct therein, or collect with other persons, in bodies or crowds, for unlawful purposes, or for any purpose to the annoyance or obstruction or disturbance of other persons.

(O) No person shall resist the Director of said park and recreation areas, or any persons designated in authority by the Director, or any police officer of the Village, in the discharge of their duties, or fail or refuse to obey any lawful command of any such persons, or in any way interfere with or hinder or prevent any such persons from discharging their duties.

(P) No person shall bring into or on said park and recreation areas, any air rifle, slingshot or any other device which emits a projectile.

(Q) The closing hour for all said parks and recreation areas shall be ten o'clock (10:00) P.M. through the months of May, June, July, and August, except when special authorization from the Playground Commission allows for an extension of time. Closing time for the months not specified above ( September, October, November, December, January, February, March and April) will be at sunset.

(R) No person shall bring or use any vehicle, or any type of model aircraft, or manually operated mobile transportation, upon any portion of the said park and recreation areas, unless such vehicles ect., are authorized by the Playground Commission. (Ord. 762; 8-4-70)
